

## **Kluwer Law International Consortia AGREEMENT**

This is to confirm the agreement between Kluwer Law International (Licensor) and (Licensee) which are acting on behalf of XXX universities.

### **Pricing details.**

- The contract will be for 3 years; January 1, 2005-December 31, 2007.
- XXX consortia members will have online access to all 18 Kluwer Law International journals for EURO YYY.
- This is a total of EURO XYZ in 2005.
- Additional members can be added at this price.

### **Conditions**

- Licensee reserves the right to terminate this agreement for any of its members by sending a written notice to Licensor before November 1 each year.
- This right is applicable only to those members who cannot satisfy its payment obligations for the next year due to substantial budget reductions.
- There will be a X% increase per year for the following two years of the contract; 2006-EURO XYZ and 2007 EURO ZZZ.
- Licensor will grant access to Kluwer Law International journals by IP or FTP delivery.
- At the end of the 3 year contract Licensor will offer Licensee a proposal based on the pricing model at that time.
- This is in agreement both Licensee and Licensor.

### **Breach, Warranties, Disputes & Miscellaneous items**

Both Licensee and Licensor agree to current practices in regard to copyright law and other similarly recognised aspects of the law, and will take all reasonable measures to ensure that the current legislation is adhered to. Should any infringement take place, the first action will be for both parties to attempt to remedy the situation within 30 days. If this is not possible, then both parties agree to arbitration administered by the International Chamber of Commerce.
